

Plea in Delhi HC against EC order a notting poll symbol to AIADMK

Issue listed for hearing today

NEW DELHI, NOV 30 -- Sideline AIADMK leaders Sasikala and TTV Dinakaran today moved the Delhi High Court against the Election Commission's decision recognising the unified AIADMK under Tamil Nadu chief minister E K Palaniswami as the real party, allowing it to use 'two leaves' poll symbol.

The plea for urgent hearing of the matter was mentioned before a bench of Acting Chief Justice Gita Mittal and Justice C Hari Shankar and sought quashing of the November 23 order of the Election Commission of India (ECI). Senior advocate Kirti Uppal, appearing for the AIADMK and Dinakaran, said the matter required urgent hearing as the poll panel's order was bad in law and needed to be set aside. Agreeing to the contention of the senior advocate, the bench listed the matter for hearing on Friday. The issue has been lingering since April in the aftermath of the announcement of by-poll to RK Nagar Assembly constituency following the death of AIADMK supremo J Jayalalitha in December

last year. The by-poll to Radha Krishnan Nagar Assembly constituency will be held on December 21.

The EC had on November 23 allotted the 'two leaves' symbol to the unified AIADMK led by Palaniswami and Pannarselvam, dealing a blow to E Madhusudhanan and others is hereby recognised, as the AI India Anna Dravida Munnetra Kazhagam, which is a recognised state party in the state of Tamil Nadu and in the Union territory of Puducherry, for whom the symbol 'two leaves' is reserved in the said state and Union territories, the poll panel had said. The plea also sought direction for initiating appropriate proceedings against Madhusudhanan, AIADMK candidate for the R K Nagar by-poll, Palaniswami, Pannarselvam and MLA Semmalai for their acts. It also sought to call for records and files relating to their dispute over the symbol.

Uppal, who was present along with advocate Amit Anand Tiwari, told the court that the poll panel has not

only given a "perverse finding but has also committed serious illegalities while arriving at the decision". "The decision making process of the ECI is contrary to the settled legal principles. The EC has treated fabricated and untested material as genuine which has resulted in the hearing being unfair and consequently contrary to the principle of natural justice and therefore the proceedings and the order are void," the plea submitted.

The order of the Commission came as a setback to deposed party leader Sasikala, who is currently serving a four-year sentence in a Bengaluru jail in a disproportionate assets case, and her nephew Dinakaran. Earlier, rival factions led by Sasikala and Pannarselvam had staked claim over the symbol. Palaniswami was then in the Sasikala camp. In an interim order in March this year, the EC had barred the two factions from using the party's name or its two leaves symbol in the by-poll. Later, a large number of legislators led by Palaniswami revolted against Sasikala and announced the merger of the two factions.

Saurashtra: Incomplete projects may come in way of BJP's bid to repeat success of 2012

RAJKOT, NOV 30 -- The ruling BJP may face headwinds in the form of resentment over incomplete projects, de-energisation and public discontent if its sterling performance in the previous Assembly polls in Gujarat's Saurashtra region.

The Saurashtra region, which goes to polls on December 9, sends 48 lawmakers to the 182-member Gujarat Assembly. The BJP had won 32 seats from the region in 2012 state polls. Opposition parties have been accusing the government of failing to complete various development works, especially canal networks and irrigation projects. Asked about this, BJP's Saurashtra region spokesperson Raju Dhruv agreed partially but claimed that many of these projects were at different stages of completion and therefore, the party needed another strong mandate to complete them. Dhruv sits in his newly set-up Rajkot office every day, holds meetings with party workers, issues statements and submits reports, mostly based on the feedback received from the party cadre on the battleground, to senior leaders.

Saurashtra, the largest region of Gujarat, comprises 11 districts. The BJP had faced an outburst of Dalit anger last year when some members of the community were assaulted by cow vigilantes at Una in Somnath Gir district and a video of the incident went viral, making national headlines. Commenting on it, the BJP spokesperson said: "We never supported the (Una) incident and always denied any links to it. We detest the incident. I do not think it will have any impact on the electoral outcome. The fallout of de-energisation and teething troubles of the Goods and Services Tax (GST) could be another worry for the BJP, which has been in power in the western state for over two decades. Rameshwar Patel, a ceramic tile trader in Rajkot, said the note went against the saffron party's plank of development-oriented governance. "The demeritisation and the GST took away my business for almost a year. Not just lost business, several labourers who used to work for me went back to Uttar Pradesh. Now my business is slowly improving, but I do not have the labour force to expand my business." On an incomplete road project, Kusum Bhat, a resident of Padadhari village near Rajkot, said: "The BJP has been in power for so many years. The last three years could have been very good as our former chief minister Narendra Modi did not become the prime minister. I do not believe in the BJP's promises. Who had stopped Modi or the party from completing these infrastructure projects?" she said.

Hizbul chief's son hurt in Bihar jail scuffle

NEW DELHI, NOV 30 -- Hizbul Mujahideen chief Syed Salahuddin's son, who is lodged in Thar jail in connection with terrorism funding case, was among the 18 prisoners injured in a scuffle with security guards, officials said today.

All the 18 prisoners, including Syed Shahid Yusuf, were injured when the personnel of the Tamil Nadu special force intervened after one of their physically handicapped officers was assaulted by three inmates at Thar central jail number 10 on the intervening night of November 21-22 during a routine check. These facts were conveyed by Thar jail authorities to the Union home ministry in a report submitted yesterday, ministry officials said. The injured prisoners are being examined by a three-member team of doctors from the AIIMS here. The jail finding team, headed by a district judge rank officer, has been constituted to investigate the entire incident. The commandant of the Tamil Nadu special force battalion deployed in Thar jail has also been asked to conduct a separate detailed probe into the incident and file an appropriate action against anyone found negligent, officials said. Giving details of the incident, the official quoting the Thar jail report said, three prisoners, including a Kashmiri, were found to be having unauthorised materials and when Tamil Nadu special force sub-inspector Muthu Pandee tried to remove them, the inmates resisted and assaulted him. As the officer, who is physically handicapped, was alleged beaten up by the three inmates, other policemen intervened in which 18 prisoners, including Yusuf, were injured.

After the incident, the team of Tamil Nadu special force was removed from the active jail duties. The jail authorities have deposited the relevant evidence, including CCTV footage, to the probe teams, the official said.

UDF slams LDF govt for buildings ordinance

Cong wants Left parties to join fight against BJP: Chennithala

THIRUVANANTHAPURAM, NOV 30 -- Senior Congress leader in Kerala Ramesh Chennithala today said CPM should join the initiative by his party to bring together "secular and democratic" forces to fight the BJP at the national level.

The Congress under the leadership of Rahul Gandhi was making attempts to forge unity among "secular and democratic forces to take on communal forces" and the right approach of CPM should be to become part of it, he said here. "People of the country wanted such a force to fight the communal and divisive forces. It seems that CPM leader Sitaram Yechury and the party's West Bengal units have taken a

positive approach to this," Chennithala told a press meet.

Asked about CPM leader Prakash Karar's opposition to such a move, he said the Marxist leader committed a blunder by withdrawing the party's support to UPA-I government led by the Congress at the Centre in 2008.

"I hope he will not repeat the blunder again," he said. The senior Congress leader said CPM lost its relevance at the national level after it withdrew support to UPA-I. CPM-led LDF is ruling Kerala while the Congress headed UDF is in Opposition. Both the fronts have ruled the state alternatively for the past few decades.

He has served as a joint director, DIG and also as the SP in the Central Bureau of Investigation (CBI), inspector general (IG)-rural, IG-railways, IG-Jaipur and as a superintendent of police in Bharatpur, Jodhpur, Chittorgarh and Dholpur.

Misceants kill girl after failed abduction bid

BANDA, NOV 30 -- Miscereants killed a 16-year-old Dalit girl after they failed in their attempt to abduct her from her home in Ailha village in Banda district, police said.

The girl, a student of class 10, was sleeping when the miscereants climbed up into the house and tried to abduct her, circle officer Baberu Om Prakash said. When she resisted, they battered her to death with stones and bricks, he said. After the girl's father and brother, who jumped to her rescue, were injured. Her father has filed a complaint against neighbours. One of the miscereants left behind his jacket and the police's investigation was based on this lead, the CO said.
