## IISCO Steel Plant to export products to European markets

**BURNPUR, AUG 31/-** Products of the state-of-the-art Universal Section Mill (USM) at IISCO Steel Plant (ISP) have been certified for CE (Conformite Europeenne) Marking Certificate by DNV GL, Business Assurance, Sweden on August 30. **Forex reserves rise by \$445.4m**

**MUMBAI, AUGUST 31/-** The country's foreign exchange reserves rose by USD 445.4 million to USD 401.293 billion in the week to August 24 on the back of increase in currency assets, RBI said on Friday. In the previous week, the overall reserves had witnessed a drop of USD 33.2 million to USD 400.84 billion. The reserves had been declining in the past few weeks as the Reserve Bank of India (RBI) is selling the US dollar to contain depreciation in the rupee, which breached the 71 mark against the greenback today, its lowest ever. ## Smartworks pumps \$20 m

**NEW DELHI, AUGUST 31/-** Co-working operator Smartworks has invested USD 20 million in the last two-and-half years on setting up 18 facilities, of which 3 are underway, to tap into the rising demand for shared office space, a top company official said. ## Coca-Cola buys coffee chain Costa

**LONDON, AUGUST 31/-** Coca-Cola Friday said it had agreed to buy global coffee chain Costa from its owner Whitbread for 3.9 billion pounds (\$5.1 billion). "Hot beverages is one of the few remaining segments of the total beverage landscape where Coca-Cola does not have a global brand. Costa gives us access to this market through a strong coffee platform," Coca-Cola chief executive James Quincey said in a joint statement.
