

Central panel on allowance submits report to Jaitley

PORT BLAIR, APRIL 29/ -The committee on allowances, constituted by the Ministry of Finance, Government of India to examine the 7th CPC recommendations on allowances, submitted its report to the Union Finance Minister Shri Arun Jaitley yesterday. The committee was headed by Shri Ashok Lavasa, Finance Secretary and Secretary (Expenditure), Ministry of Finance, Government of India and had Secretaries of Home Affairs, Defence, Health & Family Welfare, Personnel & Training, Post and Chairman, Planning Commission as its members and Joint Secretary (Implementation Cell) as its Member Secretary.

The committee was set up in pursuance of the Union Cabinet decision on 29.06.2016 when the recommendations of the 7th CPC were received in respect of

79 allowances which have been examined in detail by the Committee. In doing so, the Committee interacted with all the members of the Standing Committee of National Council (Staff Side), Joint Committee of Secretaries (JCM) as well as the representatives of various Staff Associations of Railways, Postal employees, doctors, nurses, and Department of Atomic Energy. It also interacted with the representatives of the Defence Forces, DGs of Central Armed Police Forces (CAPFs) namely CRPF, CISF, BSE ITRB, SSB, and Assam Rifles as also senior officers from IB and SPG to understand the viewpoint of their personnel. As mentioned in the Report, the Committee held a total of 15 meetings and was assisted by a Group of Officers headed by Joint Secretary (D/o Expenditure) in examining the representations.

The report, now being submitted to the Department of Expenditure, Ministry of Finance, will be placed before the Empowered Committee of Secretaries (E-CoS) set up to screen the 7th CPC recommendations and to firm up the proposal for approval of the Cabinet. It may be recalled that while recommendations of the 7th CPC on pay and pension were implemented with the approval of Cabinet, allowances continue to be paid at old rates. After consideration by the E-CoS, the proposal for implementation of 7th CPC recommendations on Allowances after incorporating the modifications suggested by the Committee on Allowances in its Report shall be placed before the Cabinet for approval.

PORT BLAIR, APRIL 29/ -Partly cloudy weather with light rainfall is likely to occur during next five days.

In South Andaman 10 mm of rainfall, in North and Middle Andaman 12 mm of rainfall and in Nicobar Island 25 mm of rainfall is expected during this period. The maximum temperature will be 33 to 36 degree centigrade with minimum temperature of 25 to 27 degree centigrade, whereas the maximum and minimum relative humidity is expected to be in the range of 68 to 76 % and 60 to 69 %, respectively in Andaman and Nicobar Islands. Weather based agro advisories from 29th April to 3rd May, 2017
For South Andaman :
Do earthing up in fruiting okra and provide irrigation to the newly sown nursery.

Clean the coconut garden and fire the waste to reduce pest attack. Provide root feeding per plant 25 ml containing 1 ml monocrotophos dissolved in 1 lit of water, after cutting the fresh root tip of the coconut tree affixed with slug caterpillar.

Provide vitamin C along with electrolyte power in drinking water to prevent heat stress during day times as hot weather will prevail.

For Nicobar: Collect the organic wastes, chop it and mix with any animal manure/glyricidia fill the compost tank. Provide vitamin C along with electrolyte power in drinking water to poultry birds to prevent heat stress during day times as hot weather will prevail.
